




Boarder Clearance _

Removal In Transit

RIT refers to the movement of goods through a country or customs territory without being subject to import duties or other customs formalities. It allows goods to be transported from one country to another through a third country without undergoing full customs clearance procedures or being subjected to customs duties or taxes in the transit country. At Luytech we provide Removal in Transit services for all neighboring countries such as Zimbabwe, DRC and Malawi.

- Machinery etc






Registration & Insurance.

In an effort to ensure a stress free process from the moment you order your vehicle to the moment you are able to drive it on public roads, we also provide vehicle registration and insurance services with RATSA and Interpol. The following proceed is undertaken,

- **a.** Customs Clearance Certificate: Issued by the Zambia Revenues Authority (ZRA).
- **b.** Interpol Motor Vehicle Clearance: issued by Zambia Police
- **c.** Vehicle Registration: Issued by The Road Transport and Safety Agency (RTSA)
- **d.** Application for Motor Vehicle License ("Road Tax"): Payment of fees prescribed in order to obtain the permission to use the vehicle on Zambia national roads and obtain the Motor vehicle license.
- **e.** Apply for Safety Inspection ("Road Fitness Test"): This inspection is necessary if the vehicle is to be allowed to drive on public roads.
